### **BUSINESS ARISING** FROM THE MINUTES

BA1 – Vancouver **Island Natural Gas** Prices

Wayne Haddow enquired how the study on natural gas prices was proceeding. Chair Marcotte reported it was left with the AVICC to work on and she will follow up at the next meeting.

Discussion took place. The Chair will look into inviting Nancy Myers, Energy Solutions Manager of Fortis BC, to a future RAAC meeting.

#### **DELEGATIONS**

D1 – Shawnigan **Cobble Hill Farmers** Institute

Rosalie Power and Lyn Jakimchuk, volunteers from the Shawnigan Cobble Hill Farmers Institute & Agriculture Society made a presentation regarding funding to resurrect the youth agriculture education program. Their mission is to educate young people in the Cowichan region about agriculture, growing your own food using sustainable practices, and to promote farming as a business and future

career. They are interested to partner with the CVRD in order to be able to provide written materials, printed matter and other financial support for educational purposes. Propose coloring/activity books for elementary students, kindergarten to grade 6.

Recognize they share a vision with the RAAC in that both have an interest in food self-sufficiency or food security in the region and environmental farm planning with regard to composting and sustainable practices. So far, they have received one grant from Island Savings Credit Union G.I.F.T. program. This funding will assist with the seed program that will be offered to both Evergreen Independent School in Cobble Hill and Discovery School in Shawnigan Lake.

Discussion took place.

Kathy Lachman noted a coloring station would fit well with the 2013 Islands Agriculture Show (IAS). The IAS and RAAC budgets will be reviewed and the Commission will contact the delegates.

#### REPORTS

### R1 – ALR Application 1-H-11

Additional photos were distributed to the members. Tom Anderson provided an overview of the application. The applicant, Mr. Ray Smith, spoke to the Commission providing background information to support his application. The Chair asked the members to consider how this application reflects with the goals and actions of the Area Agriculture Plan. The Commission will be making a recommendation back to the Electoral Area Services Committee and Board.

## C1 – Electoral Area E Bylaw Referral
