#### **Recommendation:**

#### Purpose:

To provide an update on the fundraising campaign underway for rehabilitation of the historic Kinsol Trestle.

#### **Financial Implications:**

The Cowichan Foundation is undertaking a fundraising campaign for the historic Kinsol Trestle with a target of \$2 million to be raised in addition to the \$4.1 million already secured for the project by the CVRD through funding commitments from the Province of BC and the Island Coastal Economic Trust.

#### **Interdepartmental/Agency Implications:**

N/A

#### **Background:**

In February 2009 the Cowichan Foundation and the Cowichan Valley Regional District signed a formal agreement (Kinsol Trestle Fundraising Agreement) whereby the Foundation would undertake a fundraising campaign with a target goal of raising \$2 million in funds and in-kind contributions for the historic Kinsol Trestle Rehabilitation Project. The campaign was publicly launched at the Kinsol Trestle site on Wednesday June 10<sup>th</sup> by the Cowichan Foundation Kinsol Fundraising Cabinet Chair Jack Peake and other members of the Cabinet. Information from the June 10<sup>th</sup> fundraising campaign launch, including the complete list of Kinsol Fundraising Cabinet members is enclosed as part of the agenda package.

Also attached is an update from Clayton Consulting, the fundraising consulting team that is providing the expertise and resources in support of the Cowichan Foundation's fundraising campaign, on the status of the overall Kinsol Trestle fundraising campaign. A representative from Clayton Consulting will be at the July 10<sup>th</sup> Kinsol Trestle Revitalization Committee meeting to provide additional details on the fundraising campaign and respond to questions from the Committee. The Parks and Trails Manager also continues to provide a liaison support role between the Cowichan Foundation/Campaign Cabinet and the Cowichan Valley Regional District, including attendance to meetings of the Campaign Cabinet.

The Cowichan Valley Regional District has also submitted detailed grant funding applications, each with an application request of \$1.3 million, to both the Building BC Canada Fund – Heritage Component grant program and to the Western Economic Diversification Canada Community Adjustment Fund (CAF). No response with respect to favourable consideration of one or both applications has been received to date. Further applications will be submitted to grant programs, as announced, for which the historic Kinsol Trestle Rehabilitation Project is eligible and for which the Regional District is required to be the applicant (i.e. local government eligibility requirements). The Cowichan Foundation is also pursuing grant funding for which the non-profit society is eligible to make application for the Kinsol project.

#### KINSOL TRESTLE FUNDRAISING CAMPAIGN Campaign Progress Report

July 2, 2009

Part A of the Kinsol Campaign was the feasibility study conducted in the fall of 2008 and into early 2009. Clayton Consulting submitted a feasibility study report to the CVRD recommending the \$2 million campaign and a strategy to support the campaign.

This memo is an up-date on Part B of the campaign that ran from February 2009 through the public launch on June 10 and to the end of June. This memo is also to provide a brief overview of the campaign workplan for Part C - July through December 2009.

John Kaye from Clayton Consulting will provide more information at the July 8<sup>th</sup> meeting of the CVRD Kinsol Trestle committee.

#### **Interdepartmental/Agency Implications:**

#### **Background:**

Recognition of donors, whether financial or in-kind contributions, is an important component of undertaking a successful campaign to raise funds for a project. Establishing the donor recognition program parameters early in the fundraising campaign is important, so that potential donors will know how their donations will be recognized. For the Kinsol Trestle Rehabilitation Project fundraising campaign, acknowledgement and recognition of donors is inclusive of grants funds and other contributions received by the Cowichan Valley Regional District and the donations raised (financial and in-kind contributions) by the Cowichan Foundation.

Clayton Consulting has prepared a draft Kinsol Trestle Rehabilitation Project Donor Recognition Program for consideration by the Cowichan Valley Regional District and the Cowichan Foundation (see attachment). #### **Recommendation:**

#### Purpose:

To provide a further update on the review process underway by the Ministry of Transportation and Infrastructure regarding the Kinsol Trestle Restoration Feasibility Study Phase II Report submitted by Commonwealth Historic Resource Management in December 2008.

#### **Financial Implications:**

The Ministry of Transportation and Infrastructure has committed \$1.5 million towards the Kinsol Trestle rehabilitation project, which includes a \$100,000 contribution to the Kinsol Trestle Restoration Feasibility Study (Phases I & II).

#### **Interdepartmental/Agency Implications:**

The Provincial Transportation and Finance Authority is the owner of the Kinsol Trestle and former CNR corridor.

#### **Background:**

It was reported at the March 3, 2009, Kinsol Trestle Revitalization Committee that the Ministry was undertaking a review of the Kinsol Trestle Restoration Feasibility Study Phase II Report submitted by Commonwealth Historic Resource Management (see attachment). Subsequent to the report update at the March 3<sup>rd</sup> meeting, the Ministry of Transportation and Infrastructure has twice requested additional information from the Kinsol Trestle consulting team retained by the Regional District to complete the Phase II report (Commonwealth Historic Resource Management Ltd. et. al). The consulting team has responded to these requests for information on behalf of the Regional District. The Ministry has since informed the Regional District that completion of the review of the Phase II report will be completed, at earliest, by mid-July 2009, which will be followed-up with a formal Ministry response to the CVRD. The next steps identified for the project (in particular, proceeding with the process to retain a qualified

bridge/trestle engineering firm to prepare the detailed rehabilitation specifications and work program) are subject, in part, to the response of the Ministry, as there may be conditions and/or requirements on how the rehabilitation works are to proceed that would need to be included into such work program, although it is uncertain at this time what these requirements could entail. Funding to undertake the next steps in the project is also conditional at this time on the release of the \$1.5 million in funding for the project from the Ministry of Transportation and Infrastructure.

#### **Recommendation:**

That the Committee and Board authorize final payment to Commonwealth Historic Resource Management for consulting services to prepare the Kinsol Trestle Rehabilitation Phase II report.

#### **Purpose:**

To update the Committee on the status of the Ministry of Transportation and Infrastructure's review of the Kinsol Trestle Rehabilitation Phase II report prepared by Commonwealth Historic Resource Management and Delcan Engineering.

**Financial Implications:** 

N/A

#### **Interdepartmental/Agency Implications:**

The Ministry of Transporation and Infrastructure has committed \$1.5 million towards the rehabilitation of the historic Kinsol Trestle, inclusive of a \$100,000 contribution towards the Kinsol Trestle Rehabilitation Feasibility Phase I & II Study.

#### **Background:**

The Ministry of Transportation and Infrastructure was sent a final draft of the Kinsol Trestle Rehabilitation Phase II report in early December 2008 for review/comment. The Ministry has completed a preliminary review and advised that they intend to undertake further formal review through retention of their own consulting engineers to review the report and assess the rehabilitation strategy recommended by Commonwealth Historic Resource Management/Delcan Engineering. The additional review is the result of concern raised by the Ministry with respect to their understanding of the report's indication that the \$5.7 million budget will not be adequate for the required rehabilitation and suggested that the CVRD review the contingency allowances. The strategy outlined in the Phase II report identifies that if all the rehabilitation work cannot be completed within the \$5.7 million budget that the primary work focus on the Howe truss (the eight structure bents to carry the new trail decking) and that the other trusses be rehabilitated with remaining budgeted funds and as part of delayed maintenance over the first 10 years of the trestle's operation with funds from the Kinsol Trestle Operations and Maintenance budget.

In particular, the Ministry intends to have their engineering consultants focus on further developing recommendations/strategies on how the proposed rehabilitation could proceed within the \$5.7 million budget and address how much of the rehabilitation could be delayed to future years, given that the CVRD's Kinsol Trestle Operation and Maintenance budget has a requisition maximum of \$100,000 (2009 figure). The Ministry has advised that they have not yet retained an engineering consulting firm to undertake this scope of work on the their behalf; however, the Ministry has agreed to pay out the \$100,000 towards the Phase I and II study work. In this regard, Commonwealth Historic Resource Management/Delcan Engineering have respectfully requested, due to the extended timeframe for the report review by the Ministry, if final payment for the Phase II study could be made at this time. The consulting firms have also indicated that they remain committed to the project and would be available to the CVRD and Ministry during the Ministry of Transportation and Infrastructure's further review process of the Phase II report.

#### **Background:**

The terms of the "Kinsol Trestle Fundraising Agreement" between the Cowichan Valley Regional District and the Cowichan Foundation with respect to conducting a \$2 million fundraising campaign program for rehabilitation of the historic Kinsol Trestle, includes the provision that the Regional District cover the fundraising campaign costs and expenses for the duration of the campaign. The terms of the agreement also includes provisions for partial to full reimbursement of the Regional District's expenditures, conditional upon the campaign raising the target amount of \$2 million or within set limits of this target amount. The funding to cover the capital campaign costs are provided through the Regional Parks budget, as previously approved by the Board. Any reimbursement of funds from the Cowichan Foundation upon completion of a successful campaign would be directed to the Regional Parks function. In order

to avoid a reduction in operational and capital funding for regional parks and trails sites and projects in 2009, the Regional Board approved the Regional Parks budget for 2009 to include a provision for a \$140,000 Transfer from Reserves. Policies and regulations pertaining to expenditure of Regional District Reserve Funds require the expenditure of a capital nature.

Therefore, within the approved 2009 Regional Parks budget, funding from the \$316,966 requisition are being applied to cover the Kinsol Trestle fundraising campaign costs, while the \$140,000 Transfer from Reserves are to be applied to capital project works. The major capital works under Regional Parks in 2009 is development of the Cowichan Valley Trail sections between the Town of Lake Cowichan and Duncan/North Cowichan and the section of trail within the E&N Railway corridor in Chemainus. At this time direction from the Board is required for staff to prepare the Reserve Fund Bylaw authorizing no more than \$140,000 from the Regional Parks General Reserve Fund for the purpose of these capital improvements.

# Big finish needed for Kinsol Trestle

Little did I realize, that grey, drizzling winter day years ago when I first set eyes upon the Kinsol Trestle, that I'd find myself labouring to save it from deliberate destruction.

And little did I realize what I was getting into, when that day did come in April 2006, that the Ministry of Highways and Transportation, responsible for the abandoned CNR railway grade that is now part of the Trans Canada Trail, announced its intention to demolish this magnificent structure as a safety hazard and insurance liability.

Well, here we are, three years later and, with the formal launch in June of a public fundraising drive by the Cowichan Foundation to top up the bank account to complete rehabilitation of the Kinsol, I find myself reflecting on the bumps along the road to the old girl's salvation.

It's been quite a learning curve! I mean, really, how does one go about convincing the powers-that-be that they're dead wrong on all counts: That, despite appearances, the trestle is structurally sound and worth saving, that a look-alike replica won't attract hikers, cyclists and equestrians to the Trans Canada Trail, that the trestle is not only a priceless artifact and icon of our Island industrial heritage, but a potential world-class tourist attraction? That it's the crown jewel of their proposed Cowichan Valley trails system?

Where and how to begin, as it happened, proved to be the easy part. Upon announcement of the Kinsol's proposed demolition, two newspaper editorials spurred me to action. I'm thankful for being prodded in my decision to go to war, so to speak, by comments on the editorial page of a local paper. They urged restoration not destruction, with which sentiment I agreed instinctively. But for all my passion for history, and uncomfortable at the thought that if I failed to take a stand I'd betray everything I've ever written -- preached -- over 40 years, I dithered over getting involved.

Until local editorial comment and, conversely, that which appeared in the Times-Colonist. Praising the provincial government for finally reaching a decision over the trestle's fate and the Koksilah River crossing necessary to complete the Trail, the Victoria daily urged swift replacement with a clone, what we historical "purists" came to dismiss as the Stick Bridge or the Martha Stewart Bridge.

Outraged by what I perceived to be callous indifference to our heritage, I agonized for half a day in writing a rebuttal to the T-C editorial. Did the editor truly believe that heritage structures which had reached a state of deterioration through neglect should be torn down and replaced with counterfeits? In, of all places, a provincial capital whose very character is defined by its heritage, landmark buildings

such as the Parliament Buildings, Empress Hotel, Christ Church Cathedral and scores of others?

Hardly likely! So why the double standard when it came to the Cowichan Valley's most famous icon?

One thing I did recognize from the very beginning: That an appeal to public nostalgia or sense of history, however noble those sentiments may be, just wouldn't cut it. Although I didn't seize upon the exact buzz words, heritage tourism, at the time, I took the stand then, and do now, that the secret to the salvation of the Kinsol Trestle lay/lies in its being the star attraction of the Valley's Trans Canada Trail.

This was confirmed the moment I began looking for likely allies via Google. To my joy, provincial hikers, cyclists and horseback riders had already discovered the Kinsol; a common theme of travel pieces on Vancouver Island recommended the Trestle as a must-see. Score one.

Then I made another momentous discovery: Bridges are sexy! Now, my mother had always admired pictures of covered bridges such as you see in the eastern provinces and states, and I've always been a sucker for bridges generally, but it hadn't occurred to me that many, many people, men and women, find bridges attractive. Score two.

Score three proved to be the most valuable of all: Media people fell for the Kinsol on sight. None of them had seen the trestle before the news of its impending demolition prompted their attention. I can tell you that, having led numerous camera crews, anchor people and reporters to the Kinsol, without exception they left empathetic, even supportive. They, as did so many others, saw the value in saving this monument to our railway and logging history and became the trestle's greatest allies.

Now I could re-cap all that has since transpired, from the low-point of two years ago when the CVRD staged its "Open House" to convince the public that demolition and reconstruction was the only answer, to the change of heart by the MOT which then put up much of the \$4.1 million on hand to restore the Kinsol and, subsequently, and by most CVRD directors. But I've told all this before (sometimes, admittedly, with ill-concealed emotion) and the Citizen has followed the story in its news columns.

So here we are, June 2009. It's time for members of the public who have supported the cause morally, who have for three years spoken up in the Kinsol's defence, who have button-holed me on the street with questions as to its latest status, to step forward. The Cowichan Foundation, a venerable institution in this Valley with a stellar record of raising funds for good causes (bursaries and scholarships for one) is out to raise \$2 million to complete the trestle's estimated restoration cost of \$5.5 million which includes a seed fund for regular maintenance.

At the June 10th launch at the trestle, ardent trestle proponent Jack Peake made the first donation. Let him be the first of an avalanche of support for the Kinsol Trestle! The Foundation is seeking corporate donations of cash and/or goods and services as well. # Cowichan district needs help to restore old trestle

# It will cost \$2M to fix the structure and put trail across it

The call is going out for help restoring the historic Kinsol wooden train trestle near Shawnigan Lake.

The Cowichan Foundation, a non-profit society, wants to raise \$2 million to fix the trestle and put a hiking trail across it.

Its restoration would finish the 120-kilometre Cowichan Valley Trail, the Cowichan Valley Regional District's contribution to the 200 km southern Vancouver Island portion of the Trans Canada Trail. The trail route runs from Departure Bay in Nanaimo to Victoria, where it becomes the Galloping Goose Trail.

At 44 metres in height, the Kinsol Trestle is one of the tallest such structures in Canada, but no trains have used it since 1979. Hikers using the Trans-Canada Trail now have to traverse about 10 km through difficult terrain to cross the Koksilah River.

"We're looking for support for this, quite frankly, across Canada, if not North America," said Brian Farquhar, CVRD parks and trails manager.

"We believe it is of national heritage significance."

Curving six degrees as it spans 188 metres across the gorge north of Shawnigan Lake, the 89-year-old bridge towers more than 14 storeys from the gorge bottom below, dwarfing towering Douglas firs.

It is the last and largest of eight trestles to be repaired along the rail line that was originally planned to serve Port Alberni. The line ends at Youbou, where the project was shelved during the Great Depression, then was killed after the Second World War, when automobiles supplanted rail travel.

Although the trestle is unsafe, engineers say it can be fixed with sufficient funding. The goal is to create a new 200metre pathway for hikers, cyclists and horseback riders. Unsound timbers will be replaced and the structure reinforced, but organizers plan to preserve the trestle's historic characteristics, including the span, height and timbered design qualities of the original structure.

"I look forward to the day I'm looking at the rehabilitated trestle and I'm standing in the middle of it looking down at history and booking back and forth both ways at the future," said Jack Peake, who is heading up the fundraising campaign.

The province of B.C., which owns the railway, has already committed \$1.6 million from its Localmotion funding program, \$1.5 million from the Ministry of Transportation and Infrastructure and \$1 million from the \$50-million Island Coastal Economic Trust fund created to bolster the Island economy.

The fundraising goal includes \$340,000 to create an endowment fund, which the CVRD would use for ongoing maintenance costs.
