1. Lake Cowichan/Honeymoon Bay/Youbou service update
Mr. Wakeham provided an update from meeting with BC Transit, the
operating company and Directors to discuss bettering the service.

### 2. Commuter Park-N-Ride update

It was moved and seconded that the staff write directly to the Ministry of Transportation and Infrastructure, regarding providing a noise barrier as a result of the berm that was removed for the Frayne Road Park-N-Ride.

Myrna Moore, Regional Manager, BC Transit, provided verbal updates on the following:

## 1. 2010/2011 Expansion Hours

HandyDART hours have been expanded by 1600 hours annually or 6.5 hours per day, with implementation for September 2010. CVRD approval is required. Unfortunately there is no expansion hours provided for the conventional service. The Regional Concept Plan to maximize ridership and expansion of service over 25 years was discussed.

#### 2. RFP Status

Current annual operating agreements are 5-year term with 2 year extensions. These expire on March 31, 2011. BC Transit would like to consider a two year extension to allow the concept plan to be developed and to do analysis of what other operation facilities are available, that may affect the RFP process.

It was moved and seconded that the CVRD Board approve 2year extensions to the BC Transit Annual Operating Agreements and further that the Board Chair and Corporate Secretary be authorized to sign the extension agreements.

#### **MOTION CARRIED**

#### 3. Hutchinson Road Park-N-Ride Update

Mr. Wakeham advised that seven comments/complaints have been received regarding the September closing of the Hutchinson Road Park-N-Ride. Ms. Moore advised that customers will be notified of the change through various means.

#### 4. Transit Shelter Project update

Mr. Wakeham introduced Ian Martin, representative with BC Transit who is working on the province wide Transit Shelter initiative.

Mr. Wakeham explained the challenges that this project involves and, due to the anticipated cost of the infrastructure needed for most of the shelters, the shelter funding agreement scope of the project needs amending.

Discussion took place on the advantages of the BC recommended shelter design over other structures such as wood and glass.

It was moved and seconded that the CVRD accept the BC Transit proposed standardized metal bus shelters, subject to those municipalities or Electoral Areas wishing to being exempted and to submit their own desired designs for approval.

#### **MOTION CARRIED**

It was moved and seconded that staff write to UBCM requesting that the funding agreement for transit shelters be revised from 32 to 24 shelters, due to the underestimated cost of the necessary infrastructure.

#### **MOTION CARRIED**

The suggested shelter locations will be presented at the next Committee meeting.



# Cowichan Valley Regional Transit System Custom Transit Expansion for September 2010

## **Expansion September 2010**

BC Transit has allocated 1,600 annual service hours to the Cowichan Valley Custom System. Along with these hours would be another custom vehicle to add to their current fleet of 2 vehicles.

The hours will be used as during week days only and in the following fashion:

- 7am-9am peak, the new bus will deliver 2 hours of service to alleviate the strain in the system resulting from day program subscription clients being booked into these timeslots as a daily occurrence. The current capacity of hours and vehicles does allow for very little if any non-subscription trips to take place during this time.
- 1pm-3pm peak, the new bus will deliver 2 hours of service to alleviate the strain in the system resulting from day program subscription clients being booked into these timeslots as a daily occurrence. The current capacity of hours and vehicles does allow for very little if any non-subscription trips to take place during this time.
- 5pm -6pm, the service is currently only available until 5pm. The current service does not allow for commuters or for any late afternoon transit for persons who need to use handyDART.

The total number of hours use for this increase in service is 1,430 hours. It is recommended that the remaining 170 hours be kept in contingency hours to use in the event of any unforeseen circumstances.

# Future Expansions

In the discussions with the Operator and the Cowichan Valley Regional District it became clear that the system constraints were bigger than what can be solved with the current 1,600 hours. BC Transit recommends that the Cowichan Custom system be placed back on the list for a future expansion to develop the system further in the following manner:

- Saturday Service increase by 8 hours. Estimated 416 annual revenue hours
- Sunday Service is expanded by 8 hours. Estimated 416 annual revenue hours

- Additional 2 hours per day each for the 7am-9am and 1pm-3pm peak periods. Estimated 1,040 annual revenue hours. This would include another bus for peak services.
- Extend the weekday operational hours from 6:30pm to 8pm. Estimated 390 annual revenue hours
- Total estimated hours for future expansion is 2,262

The timing of these expansions will confirmed at a later date.

## Lake Cowichan Transit Service Schedule Review

#### Introduction:

On May 18<sup>th</sup>, an information meeting took place at the Cowichan Valley Regional District office with the Lake Cowichan elected officials, Directors Ian Morrison and Klaus Kuhn, and CVRD, BC Transit and Operating Company staff to discuss potential service changes and improved connections between Routes 20 Youbou Connector, 21 Honeymoon Bay Connector and 7 Cowichan Lake.

Cowichan Lake Community Services, the operator of the #20/21 Youbou/Honeymoon Bay service, had also reported that a significant drop in ridership had occurred since the last schedule change in September 2009. The Electoral Area Directors of Lake Cowichan have requested the review of potential schedule changes with the objectives to increase ridership and better accommodate commuters traveling to and from Duncan. Improved connections for shoppers and those accessing social services were also considered in the review.

From this meeting, it was determined that a survey of current, past and potential new passengers of the Youbou and Honeymoon Bay Connector buses would be required in order to gather feedback about options to improve the weekday connections from the Lake Cowichan routes to Route #7 Cowichan Lake/Duncan. During the week of June 21-27, 2010, Lake Cowichan residents were able to complete surveys (1) on-board the bus on Lake Cowichan routes #20/21, (2) on-line on the BC Transit website and (3) at key locations in the communities of Honeymoon Bay and Youbou (i.e. post office, town halls etc).

#### Improved Connections:

Since there are currently no additional provincial funds available for service expansion, Route #20/21 service enhancements would need to be considered through service reallocation at this time. The survey provided two options for residents to consider.

Option 1 – In order to provide better connections Monday through Friday, the following changes would be necessary:

- No late Friday trip
- Elimination of mid-day Saturday trip
- No trips on Sundays
- Some mid-day weekday trip times will be modified

Option 2 – Make no changes to the current service levels until funds and resources are available for improvements.

#### Survey analysis:

A total of 122 unspoiled surveys (17 online, 105 hardcopies) were received and analyzed. Of the surveys received, 80 were submitted by current Route 21 Honeymoon Bay riders, while 39 were current Route 20 Youbou riders (most survey respondents reported using both routes, while some used neither).

- Support Option 1, breakdown:
  - > 55% of total respondents (67)
  - > 70% of the Honeymoon Bay users (56)
  - > 33% of the Youbou users (13)
- Support for Option 2, breakdown:
  - > 34% of total respondents (41)
  - > 22% of the Honeymoon Bay users (18)
  - > 41% of the Youbou users (16)

34 respondents provided written comments which strongly reflected a desire to return to the "old" way (service prior to September 2009 changes) and/or improvements to service over all.

A total of 224 passengers were carried on Routes #20/21 combined for the week of the survey which results in an average of 21 passengers per weekday (4 riders on the Friday evening trips) plus 6 riders on Saturday and 7 on Sunday.

#### Recommendations:

- (1) Firstly, given that the majority of the Honeymoon Bay respondents have chosen Option 1 (reallocate service to improve connections) while the majority of Youbou respondents have chosen Option 2 (make no changes to the current service levels until funds and resources are available for improvements), the results do not provide a clear and obvious conclusion to the survey for the region as a whole. The survey does confirm, however, that schedule changes do need to be considered overall in order to improve connections from Lake Cowichan to Duncan.
- (2) Secondly, given the fact that several additional transit service issues have also been recently brought to the attention of CVRD and BC Transit staff i.e.
  - The Youbou / Honeymoon Bay revision of services and further commuter connections to Cowichan Commons
  - The VIU campus development and startup in December 2010
  - The revision of the entire Cowichan Valley service for efficiency
  - The Area E service consideration
  - Trip timing issues that are being identified.

It is recommended that these proposed changes be reviewed as one plan and implemented within a December 2010/January 2011 timeframe.
