BYLAW NO. 2413

A Bylaw to Extend the Boundaries of the Sahtlam Fire Protection Service Area

WHEREAS the Board of the Cowichan Valley Regional District established the *Sahtlam Fire Protection Service Area* under the provisions of Bylaw No. 1773, cited as "CVRD Bylaw No. 1773 – Sahtlam Fire Protection Service Establishment Bylaw No. 23, 1997", as amended, for the purpose of providing fire protection, suppression and emergency assistance services to a defined portion of Electoral Area E - Cowichan Station/Sahtlam/Glenora and Electoral Area F - Cowichan Lake South/Skutz Falls;

AND WHEREAS the Board of the Cowichan Valley Regional District wishes to extend the boundaries of the service area to include the following residential properties:

- PID #005-717-566, Section 6, Range 7, Seymour District, Except that part in Plan 27775
- PID #002-945-355, Lot 1, Section 6, Range 7, Seymour District, Plan 27775

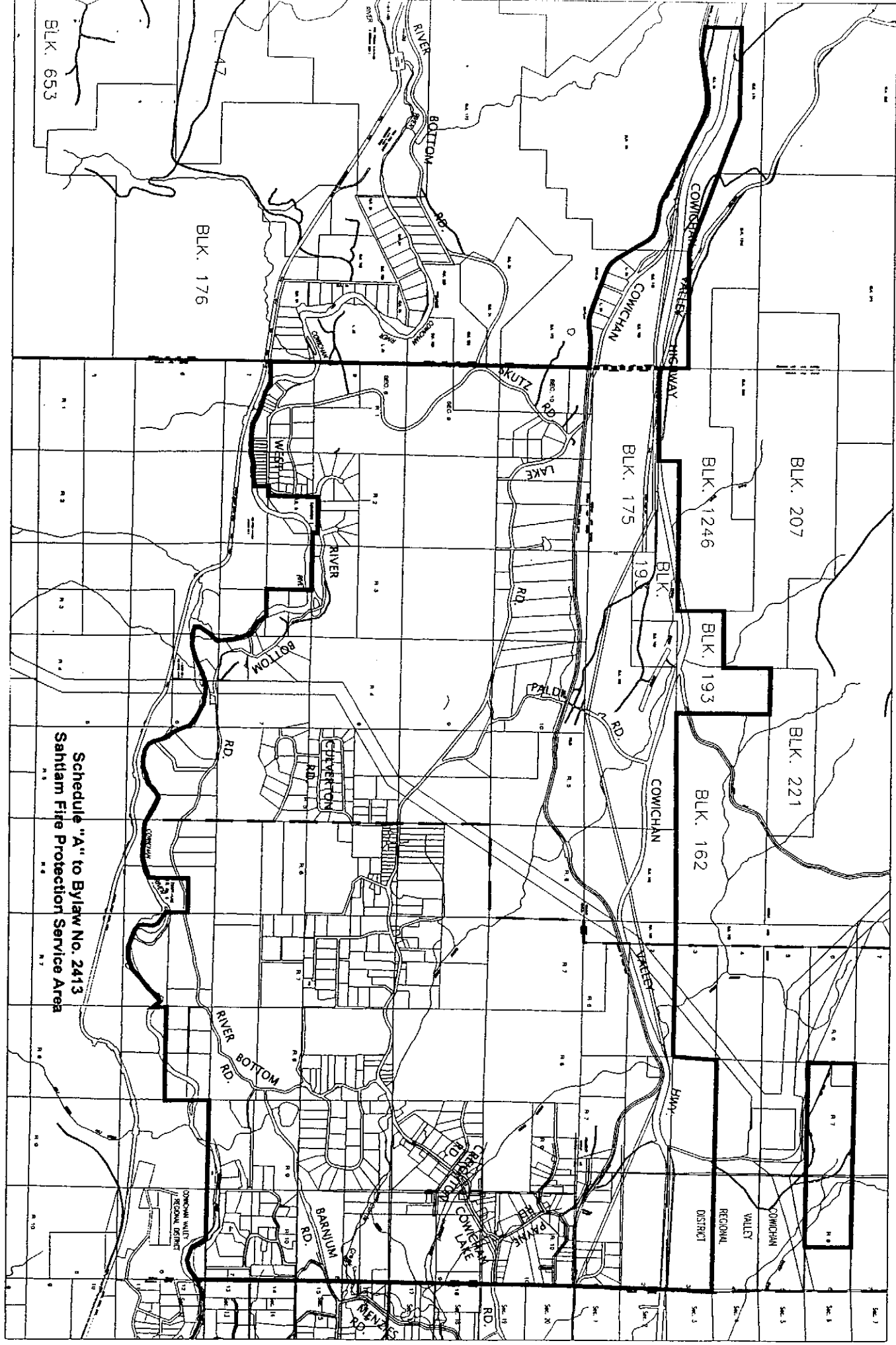
AND WHEREAS the Regional District has received a petition from the above noted property owners requesting their inclusion in the Sahtlam Fire Protection Service Area;

AND WHEREAS the Directors of Electoral Area E - Cowichan Station/Sahtlam/Glenora and Electoral Area F - Cowichan Lake South/Skutz Falls have consented, in writing, to the adoption of this Bylaw;

NOW THEREFORE the Board of Directors of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

That Bylaw No. 1773 be amended as follows:


- a) That "Schedule A" to Bylaw No. 1773 be deleted and replaced with the Schedule "A" attached hereto and forming part of this Bylaw.


