



COWICHAN VALLEY REGIONAL DISTRICT

BYLAW NO. 2664

A Bylaw For The Purpose Of Amending Official Community Plan Bylaw No. 1945, Applicable To Electoral Area F - Cowichan Lake South/Skutz Falls and I - Youbou MeadeCreek

WHEREAS the *Local Government Act*, hereafter referred to as the "*Act*", as amended, empowers the Regional Board to adopt and amend official community plan bylaws;

AND WHEREAS the Regional District has adopted an official community plan bylaw for Electoral Area F – Cowichan Lake South/Skutz Falls and Electoral Area I – Youbou/Meade Creek, that being Official Community Plan Bylaw No. 1945;

AND WHEREAS the Regional Board voted on and received the required majority vote of those present and eligible to vote at the meeting at which the vote is taken, as required by the *Act*;

AND WHEREAS after the close of the public hearing and with due regard to the reports received, the Regional Board considers it advisable to amend Community Plan Bylaw No. 1945;

NOW THEREFORE the Board of Directors of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

1. **CITATION**

This bylaw shall be cited for all purposes as "**CVRD Official Community Plan Amendment Bylaw No. 2664, 2005, Area F – Cowichan Lake South/Skutz Falls and Electoral Area I – Youbou/Meade Creek, Amendment to CVRD Bylaw No. 1945**".

2. **AMENDMENTS**

Cowichan Valley Regional District Official Community Plan Bylaw No. 1945, as amended from time to time, is hereby amended as outlined on the attached Schedule A.

3. **CAPITAL EXPENDITURE PROGRAM**





SCHEDULE "A"

To CvrD Bylaw No. 2664

Official Community Plan Bylaw No.1945 is hereby amended as follows:

1. That Section 1 be deleted and replaced with the following:

This Bylaw shall be cited for all purposes as the **"CVRD West Cowichan Official Community Plan Bylaw No.1945, 1999, Electoral Area F – Cowichan Lake South/Skutz Falls."**

2. That Section 2 be amended by deleting the words "and I".

3. That Schedule A be amended as follows:

- (a) That Section 1 INTRODUCTION, be amended by deleting the words "Electoral Area I", "Area I", or "Youbou/Meade Creek" throughout the Section.
- (b) That Figure 2 "Plan Boundary" be amended by adjusting the boundary to exclude Electoral Area I – Youbou Meade Creek from the Plan area;

4. That Schedule B be amended by deleting Electoral Area I from the Plan Map area.


