



NOTICE TO ELECTORS OF ELECTORAL AREA B – SHAWNIGAN LAKE

AVAILABILITY OF THE LIST OF REGISTERED ELECTORS

Beginning Tuesday, August 15, 2017 until the close of voting for Electoral Area Director, Area B – Shawnigan Lake on September 30, 2017, a copy of the list of registered electors will, upon signature, be available for public inspection at the CVRD Office located at 175 Ingram Street, Duncan, BC, during regular office hours, 8:00 a.m. to 4:30 p.m., Monday to Friday, excluding statutory holidays. Electors may request that their address or other information about them be omitted from or obscured on the list of electors.

ELECTOR QUALIFICATIONS

RESIDENT ELECTORS:

- age 18 or older; and
- a Canadian citizen; and
- a resident of British Columbia for at least 6 months immediately before the day of registration; and
- a resident of Electoral Area B – Shawnigan Lake at least 30 days immediately before the day of registration; and
- not disqualified by any enactment from voting in an election or otherwise disqualified by law.

NON-RESIDENT PROPERTY ELECTORS:

- age 18 or older; and
- a Canadian citizen; and
- a resident of British Columbia for at least 6 months immediately before the day of registration; and
- a registered owner of real property within Electoral Area B – Shawnigan Lake for at least 30 days immediately before the day of registration; and
- not entitled to register as a resident elector; and
- not disqualified by any enactment from voting in an election or otherwise disqualified by law; and
- **if there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non-resident property elector.**

NON-RESIDENT PROPERTY ELECTOR ADVANCE REGISTRATION

If you are eligible to vote in the 2017 By-Election as a Non-Resident Property Elector, advance registrations will be accepted in accordance with the *Local Government Act* until the closed period begins at 4:00 p.m. on August 8, 2017 and runs until October 2, 2017. Applications to register in advance as a Non-Resident can be downloaded from the CVRD website or picked up at the CVRD office located at 175 Ingram Street, Duncan, BC, during regular office hours, 8:00 a.m. to 4:30 p.m., Monday to Friday excluding statutory holidays. Eligible Non-Resident Property Electors may also register at the time of voting.

OBJECTION TO REGISTRATION OF AN ELECTOR

An objection to the registration of a person whose name appears on the list of registered electors may be made in accordance with the *Local Government Act* until 4:00 p.m. on August 25, 2017. An objection must be in writing and may only be made by a person entitled to be registered as an elector within Electoral Area B – Shawnigan Lake; and can only be made on the basis that the person whose name appears has died or is not qualified to be registered as an elector of Electoral Area B – Shawnigan Lake.
