As you may be aware, the Cowichan District Hospital Foundation (the "CDHF") is a registered society with a mandate to improve the provision of health care services at Cowichan District Hospital and Cairnsmore Place through a variety of fundraising efforts.

The CDHF is committed to bringing a new hospital to Cowichan as expeditiously as possible. I will provide you with a brief overview of our efforts in that regard below:

In 2010, recognizing the imminent need to replace the current hospital, the CDHF established a new hospital building fund. The CDHF made an initial contribution of \$1 million dollars and also passed a resolution to dedicate 20% of all future fundraising proceeds to this fund. The CDHF contributes to this fund on an annual basis.

Last year, the CDHF dedicated its annual appeal campaign exclusively to raising funds for the new hospital. This campaign included print advertising, community mail outs, events (i.e. golf tournament and dinner auction gala) as well as a trailer wrap, all aimed at raising the profile of the new hospital project in the community. This campaign was a huge success – more than doubling funds raised though the CDHF's previous annual appeal campaigns. 

Purpose/Introduction

The purpose of this report is to update the Board on the status of our three properties on Bell McKinnon Road and to obtain direction on how we should move forward on our Cowichan District Hospital replacement initiative.

RECOMMENDED RESOLUTION

- 1. That an expenditure of up to \$500,000 for Island Health to prepare a concept plan for a new Cowichan District Hospital be approved, and that this funding be part of the final Cowichan Valley Regional Hospital District (CVRHD) funding contribution for a new hospital.
- 2. That a letter be sent to the Minister of Health advising that the Cowichan Valley Regional Hospital District has \$27M in reserves; are taxing \$7M annually to pay for local government's 40% share of the cost of a new Cowichan District Hospital; owns the land which is zoned for a new hospital; and has committed \$500,000 for a new hospital concept plan.

BACKGROUND

Since our last report to the Board in early July, the Municipality of North Cowichan adopted the proposed Hospital Zoning Bylaw No. 3618 on July 20, 2016. Possession of the properties took place in September and mid-October. As such, the CVRHD now owns three properties on Bell McKinnon Road totalling 9 hectares (22 acres).

THE PROPERTIES UPDATE

The properties all have structures located on them that require our attention. The following is an update on their status. The intent is to have all the structures removed from the property in order to reduce our liability. However, as there is some life left in some of the structures, attempts are first being made to determine if any revenues can be made and, if that is not possible, then we will proceed to remove or demolish them as cost efficiently as possible.

6751 BELL MCKINNON ROAD

This 4 hectare (10 acre) property has a 2,500 square foot 1970s house, barn and two small outbuildings.

A Hazardous Materials Assessment has been completed on all structures to determine the extent of any hazardous materials such as asbestos or lead paint that may need to be removed or treated before any of the structures can be removed or demolished.

An advertisement was placed requesting offers from the general public who may be interested in acquiring and moving the house to a new location. If the house could be moved rather than demolished, the amount of hazardous material required to be removed would be substantially reduced as portions of the house could remain intact and any hazardous materials would not be

disturbed. To date there has been no interest received regarding the house. As such, it would appear that the house will have its hazardous materials removed and be demolished.

The barn has been advertised to determine if there is any interest in this structure. To date, there has been no interest expressed by the public in this structure. However, a demolition and repurposing company in Nanaimo has expressed an interest in dismantling the barn and taking the useable materials and products out of the house, advertising and selling them off the property in the Spring with revenues to be shared with the Hospital District.

The two small outbuildings located on the property are of such poor quality that they will be demolished at the appropriate time.

6771 BELL MCKINNON ROAD

This .4 hectare (1 acre) property is the smallest of the properties we have acquired. It has a small house and outbuildings and is currently being rented back to the previous owner and will be for the foreseeable future.

6793 BELL MCKINNON ROAD

This 4 hectare (10 acre) property has a 1,000 square foot 1950s house, 1,600 square foot outbuilding and two smaller outbuildings.

A Hazardous Materials Assessment has been completed on all structures to determine the extent of any hazardous materials such as asbestos or lead paint that may need to be removed or treated before any of the structures can be removed or demolished.

The house is in very poor shape and would probably not survive a move to another property. As such, meetings have been held with the Municipality of North Cowichan Fire Rescue representatives who are very interested in using the house for training their members. Ultimately, the structure would be burned as part of their final practice session. Prior to that, the house would have to be cleaned of any hazardous materials.

The large 25' x 60' outbuilding is approximately 10 years old, is 2 x 6 construction, fully insulated and has a metal roof and siding. Advertisements placed requesting offers did not generate any firm interest. As the structure is in very good shape, efforts were then made to see if there were any non-profit organizations in the area interested in dismantling and relocating this structure to another property at their expense. The Cowichan Exhibition Society has agreed to dismantle the structure and move it to their property for use as storage building(s).

The two small outbuildings are of such poor quality they will be demolished at the appropriate time.

With regard to making an effort to generate some revenue from both properties, contact has been made with the Victoria, Nanaimo and Vancouver Film Commissions to determine if there are any film companies that may be interested in using or abusing our now empty structures. Return messages indicate a real interest in such an opportunity and word has now gone out to location managers working in BC. A short period of time will be given to determine if anything comes of this initial interest.

TOWARDS ACHIEVING A NEW HOSPITAL

Meetings were held with the Provincial Minister of Health, Terry Lake in early July when he toured the Cowichan District Hospital and in September at the UBCM Convention. On both occasions, Minister Lake outlined that the next step in the process to replace our hospital is that a Concept Plan would have to be undertaken by Island Health. While positive remarks were received from the Minister that our hospital was one of the top provincial priorities for replacement, no formal

commitment has been received nor timeframe provided, to begin the next phases of the process.

ANALYSIS

There are now other valley health related organizations stepping up in efforts to increase public awareness and secure provincial funding for our new hospital. It may be appropriate for the CVRHD to take some form of leadership role to ensure that such efforts are organized appropriately.

However, at this time it is important that the CVRHD forward a letter to the Provincial Minister of Health, Premier, and Island Health, updating them on the work we have accomplished with regard to setting aside approximately \$27 million in our reserve budget and purchasing the site that now has the appropriate zoning for a new hospital. In addition, the Hospital District should commit \$500,000 towards the costs associated with undertaking the Concept Plan so that Island Health can begin work immediately.

It should be noted that while some discussions have taken place with Directors regarding funding the Concept Plan, no formal resolution has been passed committing the \$500,000 expected cost. A formal resolution is included in this report to that effect.

FINANCIAL CONSIDERATIONS

As stated above, the \$500,000 estimated cost of the Concept Planning process is available through our Reserve Budget. All costs that we have been experiencing through expenditures for technical studies, legal and consulting fees as well as purchase of the land are subject to reimbursement through the 40-60% split arrangement on Capital expenditures with Island Health and this will apply to the Concept Plan as well.

COMMUNICATION CONSIDERATIONS

That the CVRHD collaborates with Island Health on news releases regarding the CDH replacement.

STRATEGIC/BUSINESS PLAN CONSIDERATIONS

The replacement of the Cowichan District Hospital is identified as a priority in the CVRD Strategic Plan.

Re: Cowichan District Hospital - Concept Plan

I am writing to advise you that the Ministry of Health has approved proceeding with the concept plan for the Cowichan District Hospital (CDH) replacement.

The concept plan provides Island Health and the Ministry with an opportunity to consider the need for the project, alternatives for addressing the need and an assessment of financial implications (capital and operating). A completed concept plan is forwarded to the Ministry for consideration and approval before developing a more detailed business plan. The business plan is prepared for government's approval before committing to a capital project.

I understand the Cowichan Valley Regional Hospital District (CVRHD) has agreed to fund the costs of concept plan development. To the extent possible, Island Health plans to use existing staff to prepare the concept plan. However, it is expected that funding will be required for certain tasks such as data analysis and developing space requirements and a capital cost estimate. A budget to prepare the concept plan has not yet been developed but a preliminary estimate is \$300,000 to \$500,000.


