REGIONAL GRANTS-IN-AIDS

2018 Application Process

The Cowichan Valley Regional District (CVRD) is accepting submissions from qualified organizations for Regional Grantsin-Aid for 2018. To qualify, the organization must be registered as - or belong to - a parent society under the laws of British Columbia and/or Canada.

Organizations must be locally based, providing a service that benefits the residents of the region, and whose efforts are regional in nature.

Organizations applying for Regional Grantin-Aids must also provide a description of the project, event or service for which funding is requested; the beneficiaries of the project, event or service; and the total cost of the project, event or service etc. in order to have its application considered.

Grants-in-Aid Applications

The CVRD's Arts & Culture Division is distributing annual operating and special project grants for eligible non-profit arts organizations located in the Cowichan region. Arts & Culture organizations must meet the criteria listed in the Arts & Culture Disbursement Policy (www. cvrd.bc.ca/ArtsCultureGrantsInAid) and will be adjudicated by the CVRD Board-appointed Arts & Culture Grant Committee.

The goals of the Arts & Culture Grant Program are to:

- Assist community groups within the geographical boundaries of the CVRD to provide artistic programs for residents;
- Build community and organizational capacity to deliver artistic programs; and
- Promote partnerships and financial cost sharing among the CVRD, other funders and organizations.

Deadline for Arts & Culture Grant-in-aid applications is January 31. Applications can be downloaded from www.cvrd. bc.ca/ArtsCultureGrantsInAid.

All grant applications must be received or post marked by January 31 to be considered for funding. Submit completed grant applications by mail or in person to the CVRD Arts & Culture Division, Island Savings Centre, 2687 James Street, Duncan, V9L 2X5. No email applications accepted.
